Needs to be clean, dry, and solid. Otherwise use JONAS Hydro-Haft- & Tiefgrund or JONAS Acryl-Tiefgrund or JONAS Hydro PowerGrip Gel first to consolidate the underground. For underground treatment and application VOB, part C, DIN 18363 and the relevant BFS information must be observed.

Coating build-up:	Priming coat: use product without dilution or dilute with max. 5% water. Final coating: use product without dilution.
Spreading rate per coating:	Approx. 150 ml/m <sup>2</sup> on smooth underground (if necessary test on the wall).
Application temperature:	At least + 5°C (Degrees Celsius) for air and underground during application and drying.
Drying:	The surface of the coating is dry and can be painted over after 8 - 10 hours (at a temperature of 20 °C and a relative atmospheric humidity of 65 %). High humidity, low temperatures and low air exchange extend the hardenir and drying time.
Tinting:	Product can be tinted with max. 5 % JONAS Allcolor Vollton- und Abtönfarben. Adding more tinting paint migl reduce the level of gloss. Tinting may lead to deviations in the technical data, also with respect to contents of preservatives.
